Dear Mr. Russell,

It would be reasonable to say now you have been sent sufficient copies to fully understand. Mr. Harra certainly has been sent enough I regret. But before I post and have marketed throughout the UK the past 5 ½ years to the British Public for their protection, which will include homeowners and tenants, but our business ratepayers too as our new M.P has done little this last year as far as can be ascertained, I need to know please the following from you or Mr. J Harra H.M.R.C and you can if you prefer communicate through our Member of Parliament Joy Morrissey M.P

1. You proceed with the threat of legal action received from your V.O.A Director Thomas Lindie you are aware of the evidence but please do consult your legal department. In which case I will not proceed with publishing the evidence and circumstances which include corruption and abuse, not only to my wife and I but to Mr. & Mrs. Boshier at the Farm too and I will wait upon that legal process.
2. Or the V.O.A/V.T.S/H.M.R.C provide reasonable and fair compensation for the loss of my cancer support utility and the inconvenience and medical issues caused through the silence, avoidance and lies with the breaches of our legislation and the breaches of the H.M.R.C Charter. Plus 5 ½ years breaching society etiquette we all consider part of our society today and what the citizens expect from their public servants remunerated from the public purse. That intimidation to my wife necessitating the need to relocate and provide a replacement cancer support facility destroyed due to this V.O.A abuse, untruths and corruption.
3. All inclusive of the investigation required due to the silence and breaches of the Charter and Legislation, a Magistrate's gagged court appearance for purposes of the investigation. Three rigged V.T.S experiences, interfacing with the Police Service, dealing with the corrupt complaints path and colluding Council C.E.O and the contractor, taking statements, keeping this Government and H.M.R.C updated, the volume of necessary communications. Intimidation and stress to my wife far less Mrs. Boshier and her family the details of which have all been provided, and being banded (twice) a band G and (twice) a band A for reasons explained.

I would consider 28 working days would be sufficient for you commencing from Monday 22nd February 2021 to allow sign for hard copy to you and given the information and evidence provided already, if you don't make contact by then, I must and will assume you wish to do neither and I will proceed. You are now fully aware of all the evidence not only concerning your staff at V.O.A Reading CT East where it quickly became more than just a "civil" action and I have proven that well beyond reasonable doubt, but please speak to your legal team for confirmation.

I have to the very best of my ability followed the Lord Chancellor and Secretary of State for Justice and his two words of (openness and transparency) throughout, even though that was never reciprocated throughout the period
